

Snippets from Recent Club Programs

April 21 -- Flint Whitlock, 10th Mountain Division

The "Soldiers on Skis" presentation for our Kiwanis members was given on April 21. Mr. Flint Whitlock, Denver author and military historian, gave a wonderful presentation at our breakfast meeting on his book about the 10th Mountain Division that trained at Camp Hale west of Denver during WWII. The 10th Mountain Division, comprised of some the world's finest skiers, athletes, and mountaineers, was used to crack the Nazis' final and formidable defensive line to hasten the collapse of the German army in Italy. Flint is the son of a 10th Mountain Division veteran; he is the author of some three dozen magazine articles and 13 books.



April 28 -- Kevin Bell, Boulder B-cycle Program

Kevin Bell, the Outreach Coordinator for Boulder B Cycle, gave a very interesting program on how Boulder was one of the first B Cycle cities in the country when it was started in 2011 with fifty bikes and twelve stations. Today, there are 150 bikes and 22 stations with plans to expand by 70% in 2014 to 280 bikes and 38 stations. There are three full time employees and four part timers in this public/private partnership. B Cycle is a non-profit, and locations are independently owned and operated in different ways.




Denver is the largest operation currently with 600 bikes and 82 stations. The concept is growing rapidly around the country as well as outside the U.S. Each \$1,000 heavy duty Trek bike is equipped with GPS and computer software that gives ridership statistics. In 2013, 9,764 passes were sold; 91,107 miles were ridden; 4,488 gallons of gas were saved. There were 30,000 trips taken with 50% of those with cards and 50% as walkups. A ride of up to thirty minutes to and from a station is no charge. \$8.00 buys you a 24 hour pass. There are also passes for 7-day, quarter, semester, and annual usage. Bike sharing is an entrance to biking, so the biking companies are very supportive. Currently, it has been determined that 12% of Boulder workers bike to work.

SECRETARY'S REPORT: A motion was made and seconded to approve the April minutes. Report approved. TREASURER'S REPORT: A motion was made and seconded to approve April report. Passed.

GENERAL BUSINESSS: A motion was made to combine the Happy Dollars, the weekly lottery money and the coffee can money into one fund. The combined money will be used for the Project Eliminate fund. Passed

SECRETARY'S REPORT: A motion was made and seconded the April minutes be approved. Report approved. TREASURER'S REPORT: A motion was made and seconded the April Foundation Treasurer's report be approved. Passed.

NEW BUSINESS: A motion was made to give \$1,000 to Attention Homes. Passed.

- --After discussion, a motion was made to give \$200 to Katie Timmons to attend a volunteer community service project in Kenya. It was determined the project met the Kiwanis Club youth project criteria. Passed.
- --Discussion was held and a motion was made to increase the Dog Project budget by \$4,650. The project is being expanded and an increase was deemed necessary. Passed.
- --Due to an increase in qualified scholarship applicants, a motion was made to authorize the Scholarship committee to determine how the budgeted \$3,000 scholarship money will be awarded. Passed.
